Boat Rental Agreement

Release of liability for Patrick Enterprises Incorporated, its shareholders and employees and all registered DBA names.

_____ Boat owner and guests agree to hold harmless Patrick Enterprises Incorporated its share-holders and employees and all registered DBA names, from any personal injury or property damage claim resulting from boat rental. I understand that I am renting a boat at my risk and I agree to pay for all damage, personal injury claims and or death(s) arising from my actions of renting a boat. I understand that careless operation of a motorboat can cause death or serious injury to me and others. I understand that by renting a boat I am taking a risk of myself and passenger(s) life and safety and I accept that risk and will pay for all damages and claims arising from my acceptance of said risk in renting a boat. I agree not to sue for any reason. I agree that if my insurance company sues, that I will reimburse Patrick Enterprises, Inc. for all expenses incurred by Patrick Enterprises, Inc. I understand that Patrick Enterprises, Inc. carries no personal injury or property damage insurance on the boat that I am renting and I am assuming that responsibility myself in the event of death, injury, or personal property damage.

_____ I agree to return the boat before 5 PM, or late charges of \$105 per hour will accrue beginning immediately after 5 PM.

_____ Boating is limited to the upper Chain-O-Lakes and cannot be taken through the McHenry Lock and Dam.

_____ I accept the boat in the condition that it is in, I have checked the propeller and boat for damage before leaving the dock. I agree there will be no credits or refunds for any item on the boat that does not function properly.

_____ I understand there will be no refund or credit if the boat is run aground and the engine is damaged or overheated.

_____ I agree to pay for all damage to the boat and engine including parts, labor, towing, haul out, and transporting. Security deposit in the event that it does or does not cover full amount of damage will be held at the time of boat return, and an invoice for the full amount of damages will be due within 30 days of rental.

_____ I agree to pay for excessive cleaning if required at a minimum charge of \$200.

_____ I agree not to cancel any charge on my credit card for any reason.

_____ I agree to pay for damage to boat and engine if damaged due to impact with the bottom, another boat, or from abuse.

_____ I agree to understand and obey all state and local waterway regulations, and if I cause a violation, I will take responsibility for such actions.

Page 2 of **Release of Liability Agreement**

_____ I have received instructions as to the safe operation of a motorboat and understand how to safely operate the boat.

_____ Riding on the bow or body parts over the sides of the boat are not permitted.

_____ Fishing and/or any type of water sports is not allowed (waterskiing, tubing, wakeboarding, etc.).

_____ Alcohol **may not** be consumed by the driver, which is the same person renting the boat.

_____ I have inspected the boat, noted any damage to the boat and/or engine and propeller below. I agree to return the boat, engine and propeller in the same condition as when it left our dock; otherwise I risk loss of security deposit and/or additional charges.

_____ Copy of driver license is attached. Operator is at least 21 years old.
